Well another legislative session has started. A long one, with issues including funding of schools under a Supreme Court contempt order and trying to deal with a myriad of other issues.

I write this report after just watching the Seahawks win the Conference Championship over Green Bay in a game I had almost given up on by the end of the third quarter. How can we explain that amazing come from behind win?

Years ago Paul Bressi said about the TRAW that we had "The Power of The Team" and that is so true, but there is more to it than that. Things we cannot forget and be successful.

The Seahawks today, in the first three quarters had a team. That is not in doubt. What they didn't have was *TEAMWORK*. They ran around and missed receptions and didn't protect their quarterback. They were eleven players on the field not working *TOGETHER*. That is not what Paul meant when he commented about the Power of the Team.

We can't all be squabbling and disagreeing and pushing our personal agendas or side deals. We need to pull together. And we can't just sit back and expect that someone else will save the day or even do what they need to do while we don't even try to contribute and let the other side sack the quarterback or run through a hole in the line for a touchdown. We can't.

A legislative session is kind of like a game, but kind of not. With a bill having to go through two Houses of the Legislature, the House and the Senate, before the Governor even sees it, well, if we don't *WIN* the first half we don't even get to play in the second. We are on the sidelines.

Yes, the session just started, but we need you to pay attention *NOW*. We need you to help us *NOW*. When we ask you to contact Legislators with a message we give you, we mean you need to do it *NOW*. If we ask you to call, don't just send an email because you are too busy. If we ask you to send an email don't just assume someone else can do it because you are too busy. If we ask you to come to Olympia for our reception or to testify, don't expect someone else to do what you won't make an effort to do.

If you don't take this seriously, you cannot complain if we fail. You are the Green Bay Packers and won't be in the Super Bowl.

Two bills you need to act on now are Senate Bill 5207 sponsored by Senators Liias and King and House Bill 1195 sponsored by Representatives Rodne, Clibborn, Buys and Pollet. They both are *OUR* bills to allow RTTO's to close for an hour for lunch if they leave a phone number on the door and come back in a half hour if they are called. *CALL YOU LEGISLATORS NOW!* Tell them to please support both these bills. Don't wait until the second half or you will be too late. We will *LOSE*.
